# Inaugural Chair in Cooperative Enterprises, Assistant Professor in Business

- In my capacity as Inaugural Chair in Cooperative Enterprises, efforts were made to collaborate with six funders and the provincial government of Manitoba, who formed a Chair Advisory Committee. For the research component see below. The Chair initiative was an intensive undertaken to spearhead the mainstreaming of the subject area across the university, entailing the curation of an academic offer in Business studies specializing in the management of nonprofits and cooperatives called "Concentration in cooperative enterprises" with a full curriculum and the design of syllabi for each newly introduced course. Existing course syllabi were meticulously revised and updated with the most recent bibliography and textbooks, as previous syllabi's bibliographies were dated 30 years prior.
- The curriculum development was completed in 2014, as three new course syllabi were researched, developed and approved: (a) Management of Cooperative Start-Ups, (b) Social Finance, and (c) Advanced Management of Cooperative Enterprises. In addition, as Chair and Assistant Professor of Cooperative Enterprises, one teaching module was developed and shared with all Department instructors. Each course was met with full approval by the Department of Business and Administration, as evidence of the endorsement of the entire Department on all courses pertaining to cooperative enterprises, including the fourth-year course essential for the future Concentration in Cooperative Enterprises within the BBA, in December 2014. One course was awaiting approval from the University Senate at the end of that year. Ten courses were further identified in other faculties that could serve for the future Concentration in Cooperative Enterprises. The course syllabi underwent extensive review by all relevant professors and garnered letters of support from the Head of the Business Department.
- During this period, active membership participation was held in both the Department Curriculum Committee and the University Senate Budget Committee. Besides, the University Library's offer for future specialization was reviewed in collaboration with the librarian, and I donated material to augment the library's offerings related to the Chair.
- Lectured the following undergraduate courses, with two courses per trimester (onsite and online at

the same time), with a average of about 75 to 80 students each time: 1) Introduction to Business, 2) Management of NGOs - nonprofits, and 3) Management of Cooperatives.

- During the period, I oversaw the learning of 215 students, with an average of one student assistant
- per course of about 40 students. Two research students were trained for four to six months (a Manitoba University Master student and a Winnipeg University Master student). In addition, as Chair, I helped create one training position for one university student at Assiniboine Credit Union.
- Besides, I was guest lecturer at the Department of History and at the Global Development Practicum led by University President Lloyd Axworthy.
- The development and grading methods for the exams were reviewed.
- I used the constructivist approach as a method of experiential learning, inviting representatives of 14 cooperatives and associations to teach and discuss their experiences with the students in class.
- I organized and conducted two university public seminars, one with a professor from the University of Saskatchewan, and the other with a representative of the Mondragon Cooperative Corporation.
- As Chair, I was invited to present at several prestigious academic and professional events, including
  the Sobeys School of Business at St. Mary's University in Canada, the Governance Week at the
  University of Pretoria in South Africa, the European Conference on Social Economy and Social
  Enterprises in Athens, Greece, the UN Expert Meeting on Cooperatives for the Post-2015
  Millennium Goals in Nairobi, Kenya, and the Forum 5 of the International Summit of Cooperatives
  in Quebec.
- Administrative Chair responsibilities encompassed the drafting and revising of documents, including minutes, annual reports, and various other documents. Communication and response to the Chair Advisory Committee work also formed a part of the responsibilities, along with the organization of meetings. The design and construction of material for the Website pages for the Chair in Cooperative Enterprises was also part of the responsibilities, as well as informational leaflets and printing materials were also part of my responsibilities.
- Community work included attendance and contribution as an expert stakeholder to the Manitoba Provincial Plan for Cooperative Development.
